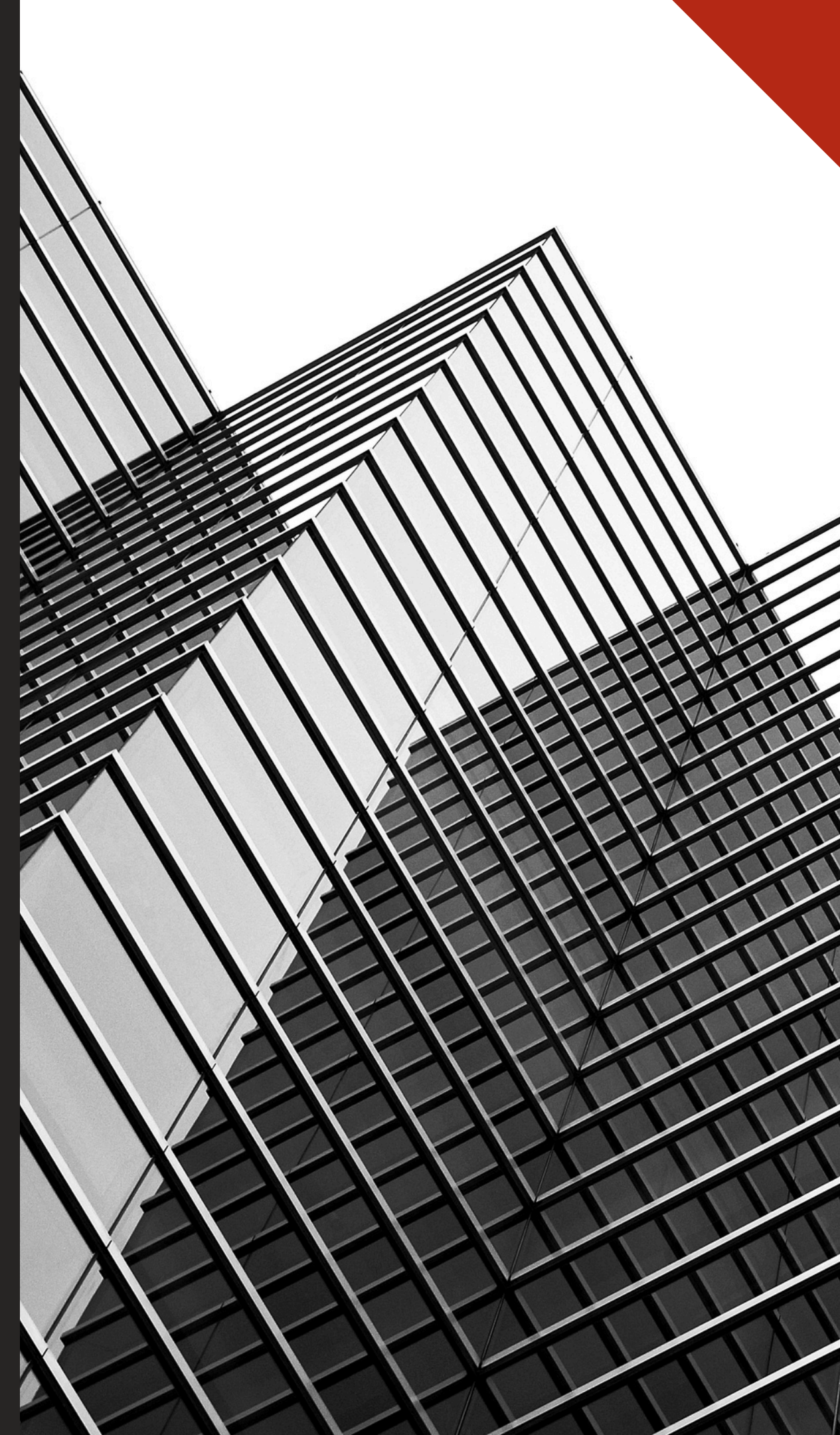

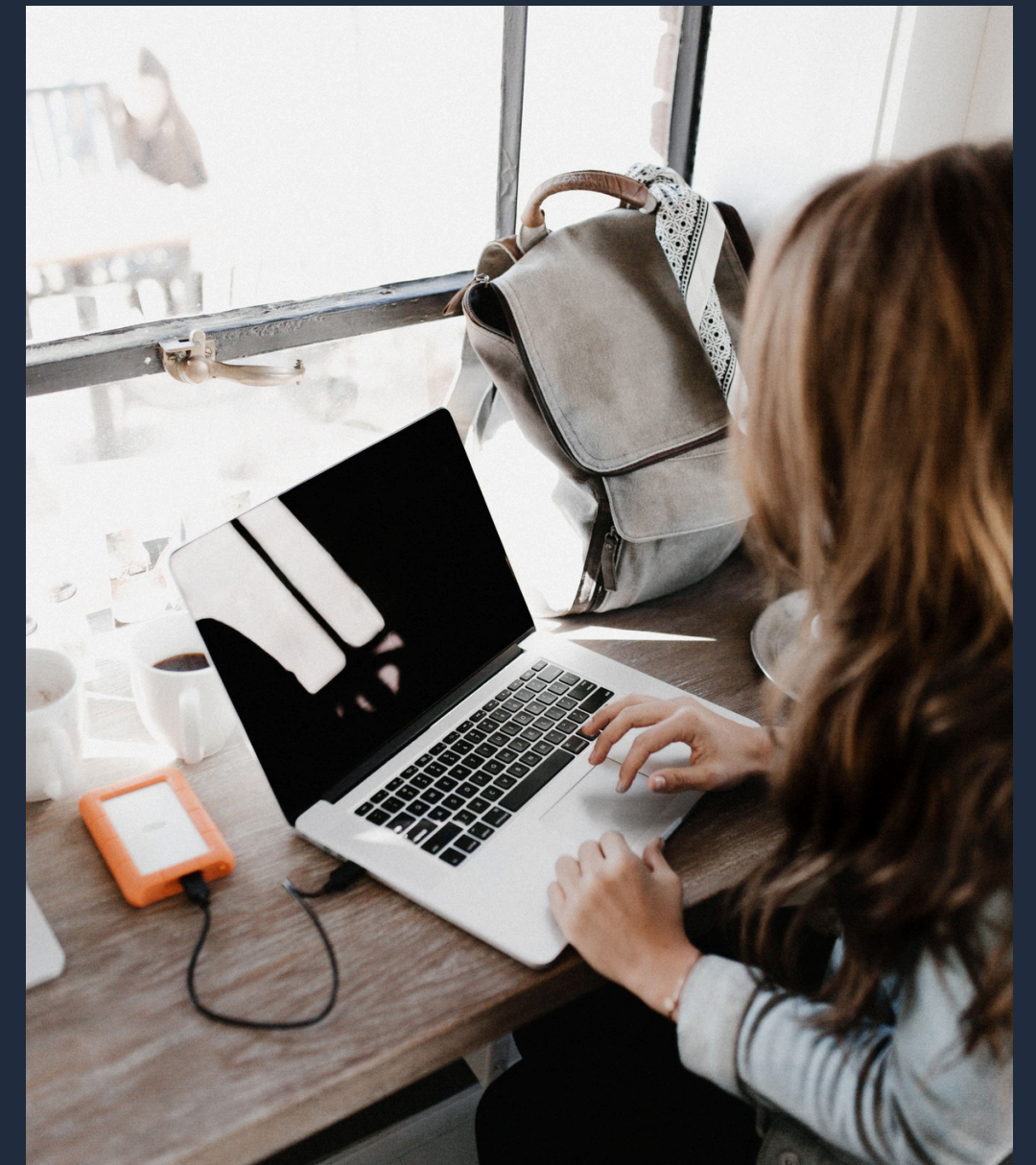

WELCOME TO THE INVESTOR VISA

The Investor Visa is not subject to the annual entry quotas established by the Italian Government. Therefore, the application can be submitted at any time, **without quota limitations**.

To obtain the investor visa, it is initially necessary to obtain a ***Nulla Osta*** (authorisation) for the visa, which is issued through the **PORTAL investorvisa.mise.gov.it**.

Our Legal Firm will be in charge of the management of the whole procedure, that is fully centralised, as a single administration manages all communications with the other authorities involved.

Documents and information **required:**

- Contact information
- **Digital signature required**
- Copy of passport
- **Applicant's CV**
- Description of the type of investment
- Proof of ownership of the funds to be invested
- Proof of **absence of criminal convictions** and pending lawsuits
- Description of the investment characteristics and **declaration of consent** released by applicant

VISA APPLICATION VERIFICATION

The **Committee** conducts a preliminary **review** of the application, followed by an **evaluation** by the Committee itself.

Then, the Committee issues the **Nulla Osta** for visa, usually within 30 days of the application submission.

Finally, the applicant has **6 months** to present himself at the **Italian Diplomatic Authority** in the country of residence and apply for the **Investor Visa**.

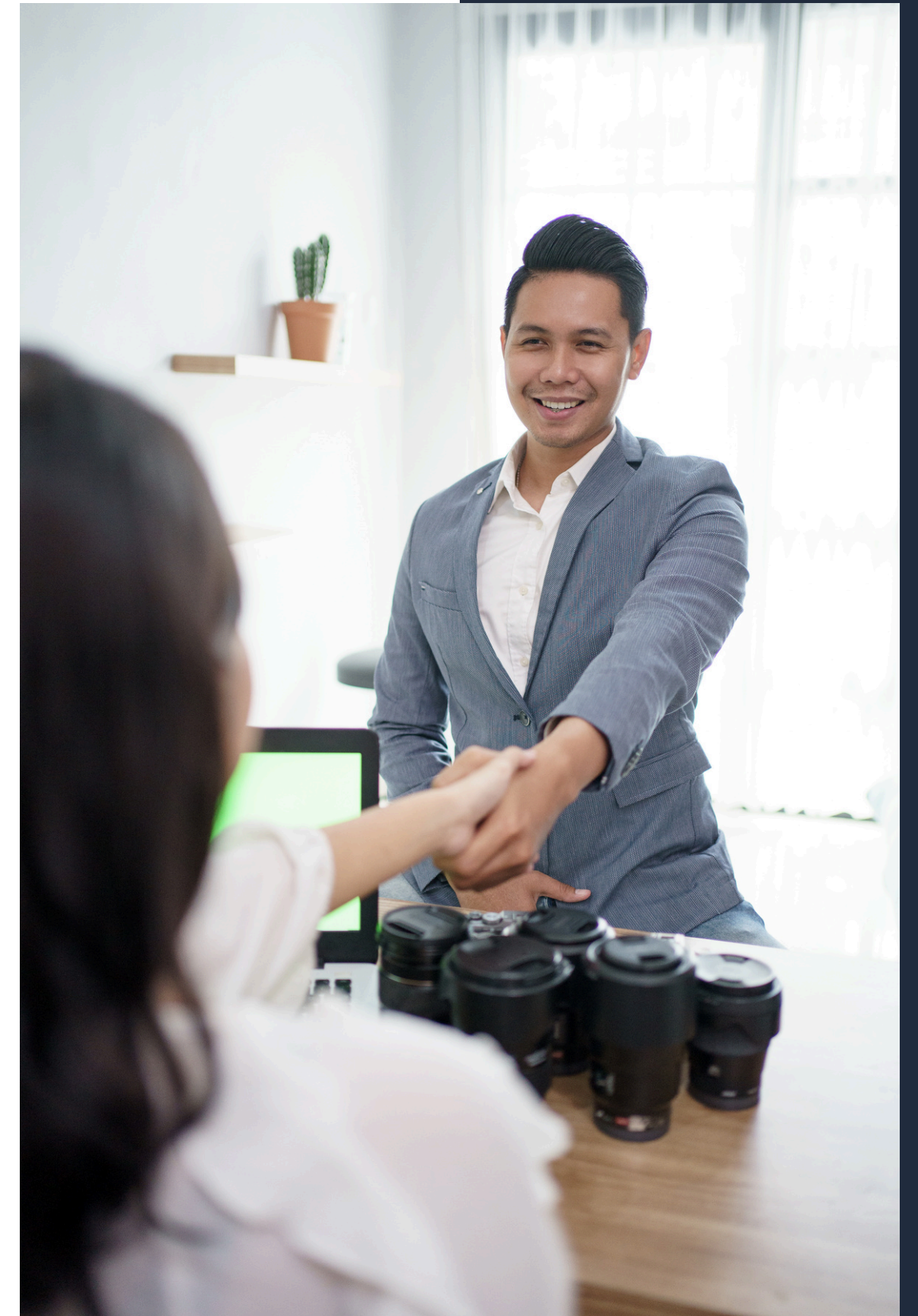

at the Immigration Office of the
Questura (Italian Police Headquarter).***



RESIDENCY PERMIT FOR INVESTORS

WHAT DO YOU NEED

- Valid passport with Investor Visa,
- Nulla Osta (Certificate of No Impediment),
- Application form for residence permit,
- 4 passport-size photographs,
- Proof of accommodation in Italy (rental agreement, hospitality declaration, etc.),
- Copy of health insurance policy,
- Receipts for payment of fees and tax stamps (marca da bollo): €30.46, €50.00, €16.00,
- Any documentation related to the **declared investment**



APPLICATION, SUBMISSION SCHEDULING

Upon submitting the application, a receipt will be issued as a temporary residence permit, allowing you to:
